**Department of Transportation
Training for Safe Transportation of Hazardous Materials
(HM126F Training)**

Section 172.704 of CFR, Title 49 requires shippers and offerors of hazardous materials (including hazardous waste) to train each "HazMat Employee" in the safe transportation of hazardous materials. According to statistics gathered through the hazardous materials incident reporting system, human error causes most of the transportation accidents involving hazardous materials. If your company's employees perform any of the below-listed job functions, your company is a "HazMat Employer" and is required to adequately train and test those employees. The DOT definition of a "hazardous material" includes hazardous wastes and therefore, if your company offers hazardous waste for shipment on a manifest, your company comes under this requirement.

Currently, the California Highway Patrol (CHP) normally audits only transporters for compliance with these federal regulations on a State and local level and usually only in cases of an incident or an accident. These audits may or may not find a trail back to the offeror of the hazardous materials. However, with the passage of Docket HM-200, enforcement will come under the authority of the U.S. DOT, Federal Highway Administration, Office of Motor Carriers, and will include those who offer hazardous materials for shipment as well.

DOT Training Requirements

Section 172.704 of CFR, Title 49 sets training requirements for workers involved in all modes of transportation (over the road, rail, aircraft, or vessel) of hazardous materials. The purpose of this training is to ensure that each HazMat employer trains HazMat employees regarding safe practices in the following areas:

1. Loading, unloading and handling of hazardous materials
2. Preparing hazardous materials for transportation
3. Storing hazardous materials
4. Transporting hazardous materials
5. Emergency preparedness for accidents involving hazardous materials

The standard requires that employers:

1. Provide training to all employees with HazMat duties,
2. Test participants on each section of required training, and
3. Document and keep accurate records of all training and testing.

The following are defined by the DOT:

HAZMAT EMPLOYER means one that uses one or more of its employees in connection with:

- ❖ Transporting hazardous materials in commerce;
- ❖ Causing hazardous materials to be transported or shipped in commerce; or
- ❖ Representing, marking, certifying, selling, offering, reconditioning, testing, repairing, or modifying containers, drums, or packaging as qualified for use in the transportation of hazardous materials.

HAZMAT EMPLOYEE means a person who is employed by a hazmat employer and who in the course of employment directly affects hazardous materials transportation safety. The term includes an owner-operator of a motor vehicle that transports hazardous materials in commerce. This term refers to an individual, including a self-employed individual who, during the course of employment:

- ❖ Loads, unloads, or handles hazardous materials;
- ❖ Tests, reconditions, repairs, modifies, marks, or otherwise represents containers, drums or packaging as qualified for use in the transportation of hazardous materials;
- ❖ Prepares hazardous materials for transportation;
- ❖ Is responsible for safety of transportation;
- ❖ Is responsible for safety of transporting hazardous materials or
- ❖ Operates a vehicle used to transport hazardous materials.

Introductory Training

Training of all existing HazMat employees should have been completed by October 1, 1993. Newly employed HazMat employees must be trained within 90 days of their employment.

Recurrent Training

A HazMat employee shall receive the training required at least once every three years.

A record of current training, inclusive of the preceding three years, shall be created and retained by the HazMat employer for each hazardous material employee for as long as that employee is employed by the employer as a HazMat employee and for ninety days thereafter.
